



OFFICIAL TERMS & CONDITIONS

MCB Caribbean Legends Pro-Am 2026

Blue Bay Curaçao Golf & Beach Resort

These Terms & Conditions govern participation in the **MCB Caribbean Legends Pro-Am 2026** (the “Event”), hosted at Blue Bay Curaçao Golf & Beach Resort, Curaçao.

By submitting a registration form and/or making payment, the participant (including any individual, team, sponsor, corporate entity, guest, or representative) agrees to be legally bound by these Terms & Conditions.

1. ORGANIZER

The Event is organized by **Blue Bay Curaçao Golf & Beach Resort**, Curaçao (the “Organizer”), in cooperation with the Legends Tour organization.

2. APPLICABLE LAW & JURISDICTION

These Terms & Conditions shall be governed by and construed in accordance with:

- The laws of Curaçao
- The Civil Code of Curaçao (Burgerlijk Wetboek Curaçao)

Any disputes arising from or related to the Event shall be submitted exclusively to the competent courts of Curaçao.

3. REGISTRATION & CONFIRMATION

- Registration is valid only upon submission of the official registration form.
- Participation is confirmed only after receipt of payment or written confirmation by the Organizer.
- The Organizer reserves the right to refuse, cancel, or revoke registration at its sole discretion.
- Participation rights are personal and may not be transferred without prior written approval of the Organizer.

4. PAYMENT TERMS

4.1 Fees

All participation fees are stated in USD unless otherwise indicated.

For administrative purposes, a standard exchange rate of 1.80 USD to XCG may be applied where relevant.



4.2 Payment Schedule

Payment is due within fifteen (15) days after invoice date.

Full payment of all participation fees must be received by the Organizer no later than seven (7) calendar days prior to the official start date of the Tournament.

Failure to comply may result in cancellation of participation.

4.3 Payment Methods

All payments must be made exclusively by bank transfer to the official bank account of the Organizer as stated on the issued invoice.

Payments by credit card, cash, cheque, or any other method shall not be accepted unless explicitly approved in writing by the Organizer.

All bank transfer charges, intermediary bank fees, and currency conversion costs are the sole responsibility of the participant. The Organizer must receive the full invoiced amount without deduction.

4.4 Late Payment

Failure to meet payment deadlines may result in cancellation of participation and/or additional charges.

5. CANCELLATION POLICY

All cancellations must be submitted in writing to:

Refund structure:

- More than 30 days before Event: 75% refund
- 30–15 days before Event: 50% refund
- Less than 15 days before Event: No refund

Refunds, if applicable, will be processed within a reasonable time after confirmation of cancellation.

6. FORCE MAJEURE

The Organizer shall not be liable for delay, modification, suspension, or cancellation of the Event due to circumstances beyond its reasonable control, including but not limited to:

- Natural disasters
- Severe weather conditions
- Governmental restrictions
- Travel bans
- Public health emergencies



- Political instability
- Acts of terrorism
- Labor disputes

In such cases, the Organizer may:

- Reschedule the Event, or
- Convert participation fees into credit for a future edition.

No additional compensation shall be due.

7. EVENT PROGRAM & FORMAT CHANGES

The Organizer reserves the right to modify the Event program, schedule, format, tee times, pairings, number of rounds, or related activities due to operational, weather-related, safety, commercial, or other reasonable considerations.

Such changes shall not entitle participants to refunds or compensation.

8. TRAVEL, VISA & ENTRY REQUIREMENTS

Participants are solely responsible for arranging and financing their own travel, accommodation (unless explicitly included), visas, entry permits, vaccinations, and compliance with immigration requirements applicable to Curaçao.

The Organizer shall not be liable for denied boarding, visa refusal, travel disruption, or inability to enter Curaçao.

9. HEALTH, FITNESS & INSURANCE

Participants confirm that they are physically fit and medically able to participate in the Event.

The Organizer strongly recommends that participants obtain adequate travel insurance, medical insurance, and personal liability coverage.

The Organizer does not provide individual accident, medical, or travel insurance coverage for participants.

10. LIABILITY

Participation in the Event is entirely at the participant's own risk.

The Organizer shall not be liable for:

- Personal injury
- Illness
- Loss, theft, or damage to property
- Travel disruptions
- Accommodation issues outside Organizer control



Liability of the Organizer shall be limited to the amount of participation fees paid, except in cases of gross negligence or intentional misconduct under applicable Curaçao law.

11. DATA PROTECTION & PERSONAL DATA PROCESSING

Blue Bay Curaçao Golf & Beach Resort acts as data controller.

Personal data processing is conducted in accordance with:

- The National Ordinance on the Protection of Personal Data (Landsverordening bescherming persoonsgegevens – LBP) of Curaçao

Personal data may be collected and processed for:

- Registration and accreditation
- Administration and communication
- Payment processing
- Accommodation coordination
- Security and access control
- Media and promotional purposes

Participants may request access, correction, or deletion of personal data where legally permitted.

12. MEDIA & IMAGE RIGHTS

By participating in the Event, participants acknowledge and agree that photographs, video recordings, livestreams, and broadcasts may take place during the Event.

The Organizer and the Legends Tour are irrevocably authorized to use participants' names, likenesses, images, video recordings, voice recordings, and related materials for promotional, commercial, marketing, archival, and broadcast purposes worldwide, in any media format, without additional compensation.

13. TOURNAMENT RULES & CONDUCT

Participants agree to comply with:

- Official Legends Tour tournament rules
- Local course regulations
- Instructions from tournament officials and staff

The Organizer reserves the right to remove or disqualify any participant for misconduct, unsportsmanlike behavior, safety violations, or failure to comply with instructions.

No refund shall be granted in such cases.



14. SPONSORSHIP & COMMERCIAL RIGHTS

Sponsorship benefits and commercial rights are governed exclusively by separately executed sponsorship agreements.

These Terms & Conditions do not create additional sponsorship rights or commercial entitlements beyond such agreements.

Participation in the Event does not create any partnership, joint venture, agency, or employment relationship with the Organizer.

15. SEVERABILITY

If any provision of these Terms & Conditions is found invalid or unenforceable under Curaçao law, the remaining provisions shall remain in full force and effect.

16. ACCEPTANCE

By submitting the registration form and/or making payment, the participant confirms that they have read, understood, and agreed to these Terms & Conditions in full.
